CHURCH COUNCIL SUMMARY

Church Council Notes Sunday, October 13, 2019

- Ministry report (Bill): 8 visits, 1 Avanti service, Pet Blessing service. Council strongly encouraged to note and greet visitors; in coffee hour, no one should sit alone
- Treasurer's report: attendance up, offerings up. Portico health insurance has increased by 6%; Polka service/fest funds to be reported at next Council meeting
- Pet Blessing service: 21 people, 15 dogs; Karen Petersohn took care of all equipment. Poor weather, little advertising. Sharon to take charge of this event for next year; date for next year to be changed to September 20, 2020 at 4 PM; \$207 donated
- Parish House: sale proceeding, buyers in process of financing; hope to close at end of October; inspection called for new well cap, contractor to do next week; did not pass septic inspection, buyers to take care of, \$1000 credit toward purchase price
- Jeanne Kroll to pursue finding service for total facility deep cleaning
- Sign, landscape plan, new entryways for side doors: actively pursue once Parish House is sold
- Security plan information from Church Mutual: alarm behind altar on hold, to be further discussed at next meeting
- Baptismal font: Mike Everson to have it finished in time for Oct. 20 Baptism, will add wheels for easy mobility
- Sale of hymnals: on hold
- Shelter shingles: Mike Pockat to do in spring
- Snowmobile trail update: Town Board in agreement, Snowmobile club will purchase and install necessary signage as per club president
- Mitten Tree: point person Karen Carter to work with principal at St. Germain Elementary for "wish list", to start immediately after Thanksgiving
- Screens for service: will not proceed until and if technical personnel are in place
- On-line giving: in process, Barb Cashman to have details at next Council meeting
- Bret and Frisk recap: slightly less attendance and offerings; \$1738 donated for youth ministry services; Bet and Frisk contracted for August 30, 2020
- Eagle Scout project: Bill Sima asked for possible projects for candidate in his troop. Suggestions include: Mitten Tree, January Chili supper (to benefit Vilas County Humane Society).

 Note: project must be candidate's from start to finish

God's Love by Elaine Kuhlmann, NGLSWO Board Member

Psalm 100:4 - For the Lord is good; his steadfast love endures forever.

Learning to cope with life without the one you love can be very hard at times. People say give it time, things will get better, he's in a better place, it was God's will.

I need him too, but God knows more than I and knows my faith in him will get me through. So when I question why things happen, I turn to prayers and guidance from God. The faith I have in God and I know his love will endure forever.

A Sincere "Thank You" by Karen Carter

Psalm 9:1 "I will give thanks to You, Lord, with all my heart; I will tell of Your wonderful deeds."

In preparation for his son Evan's first job interview, John handed his son a package of thank you cards, for him to send out after he'd met with prospective employers. He then pretended to be a hiring interviewer, using his decades of experience as a manager to ask Evan questions. After the role-playing, his son tucked several copies of his resume into a folder. He smiled when his dad reminded him about the cards. "I know," he smiled. "A sincere thank you note will set me apart from all the other applicants."

When the manager called to hire Evan, he expressed appreciation for the first hand-written note he'd received in many years.

Saying "thank you" can make a lasting impact. The psalmist's heartfelt prayers and grateful worship were preserved in the book of Psalms. Though there are one hundred fifty Psalms, these two verses reflect a strong message of thankfulness: "I will give thanks to You, Lord, with all my heart; I will tell of Your wonderful deeds. I will be glad and rejoice in You; I will sing the praises of Your name, O Most High." We will never be able to finish expressing our gratitude for all of God's wonderful deeds. But we can start with a sincere "thank you" through our prayers. We can develop a lifestyle of grateful worship, praising God and speaking of all He promises to do.

Suggestion: get in the habit of writing down prayers of thanks; doodle symbols of things for which you are thankful. These can help you cultivate a spirit of gratitude in all circumstances.

Generous and loving God, help us to recognize the countless and wonderful ways You work in our lives each day. In the name of Jesus, Amen.

DISCIPLESHIP

Worshiping God is the third mark of discipleship

Worshiping God strengthens and builds a disciple's connection to and relationship with God and the community of faith. This lesson will reflect on the importance of true worship.

Sometimes true worship is confused with the habit of "going to church." There is also the popular belief that an individual can worship sufficiently alone. However, Jesus, the Son of God, made worship central in his life and ministry (Luke 4:19). Jesus' example makes any rational excuse for not coming to worship meaningless or self-serving. Worshiping God in community was a regular in the lives of Jesus' disciples. Read John 4:19-26. This story picks up in the middle of Jesus' conversation with the Samaritan woman at the well. After a rousing round of riddles about water, the conversation shifts to an even deeper subject - worship. The Samaritan woman brings it up in an attempt to change the subject and move the spotlight away from her, but Jesus tells her that "the hour is coming" when worshiping God will not be focused on a particular location but centered in the way in which we worship God, in spirit and truth. Worshiping God with a genuine and sincere heart is what in most important.

Reflect on how the Holy Spirit inspires you to worship.

Next, review verses 17-20. Think about the phrase "in spirit and truth." What happens when your deepest hurts or needs connect with worship? Just like the Samaritan woman, you may have strong beliefs about worship. What are some common worship practices in your congregation that may cause tension or bring healing?

Practice worshiping God in spirit and truth. It will help you to discern the meaning of worship in your daily life. Read again John: 19-26 and Hebrews 12:28b. Remember that through worship we experience God's love and grow in appreciating the amazing gifts that God has given to us.

RECIPE CORNER

Some years ago I decided to give up on the frantic baking of multiple types of cookies at the holiday season. There are, however, a couple of favorites I need to make. This is one of those that has been in our family traditions since I was a child.

Toffee Squares

1 cup butter
1 cup brown sugar (light or dark will be OK)
1 large egg yolk
1 teaspoon vanilla
2 cups flour
1/4 teaspoon salt
1/2-pound chocolate (or more)
(I use Nestle's semi-sweet chips)
1/2 cup chopped nuts

*Cream butter, add sugar and beat well. Add egg yolk and vanilla and blend Add flour and salt and mix Spread on cookie sheet Bake @ 350 for 20 min.

After cooling 5-10 minutes, spread with *melted chocolate, sprinkle with nuts.

*Notes: This is a very dry recipe. Since I do not have a stand mixer with a strong motor, I work it all in by hand, especially the flour. I do not melt the chocolate, but rather just sprinkle on the chocolate chips and let them melt. When melted, spread evenly, sprinkle with nuts. While the chocolate is still warm, I like to press the nuts down in the chocolate a little so they adhere better.

Recently I have started baking this in a large cake pan. Watch time carefully – do not overbake. Our tradition is to cut them into diamond shapes.

TREASURER'S REPORT

Financial Reports

I've had several conversations in recent weeks that have indicated an interest in providing the congregation as a whole more general financial information. As your Treasurer, I do provide several reports to your Council every month and this information is available to anyone who requests it or who attends Council meetings (and I do encourage you all to attend whenever possible). As always, the financial statements are open to anyone who requests to see them. Please do not hesitate to ask if you are interested. We do try to list donations every week in the bulletin as our schedules allow. Please remember, your counters, Financial Secretary, and Treasurer are all volunteer positions and we do sometimes take a week or two off.

All of the general financial information (excluding individual donation information) is open to anyone who is interested. But that doesn't solve the issue of a way to give the congregation a general overview of finances on a routine schedule, so this is what we've come up with. Each month as timing of statements allow, I'll try to provide an income statement for the past month and a chart showing the year-to-date income and expenses, budgeted expenses, and a comparison to last year. As most of you know, tax season is a busy time for me, and I can't promise this comparison report every month for January through May. I will do my best.

Donations

Giving for general funds is considerably below what it was last year, even if we do have more people attending services. The numbers are contribution Income for the period of January 1st through October 31st, 2019 at \$92,021.49 vs. the same period of 2018 at \$103,637.63. There are several reasons for this and we've been assured that we are not the only church facing this issue. It is a widespread issue with churches across the nation. Our response to this is to cut general fund costs wherever we can. We will no longer have any costs associated with the Parish house and that will help a little. We are meeting all of our expenses and obligations and have money in the bank that can be used if needed. Currently we are doing well. Our benevolence giving is comparable to last year and we are more involved in community outreach, which is our mission.

Pay Pal for Donations

Just as technology has increased in our daily lives from home to work, we are working on increasing our use of technology here at our church. The website has been updated greatly over the past two years and now we are adding another layer.

As of December (if not yet in November) we will have the ability to accept on-line donations for Shepherd through Pay Pal on the church website. This increases the methods of giving to cash and checks, automatic payments through Vanco Services, and now Pay Pal. Automatic giving through Vanco Services can be arranged at any time just by asking me for a form and we have a minimal monthly fee for using this service. Pay Pal, just as any online payments, will have a service charge attached to each donation.

Parish House

The Parish house is no longer owned by Shepherd of the Lakes; the closing date for the sale of the property was October 31, 2019. The property had a recently assessed value of \$155,000.00, but the property did need to be updated and therefore the listing price on the property was \$149,000.00. We received a full listing price offer. The home inspection showed two areas needing repair: the well cap needed to be replaced, which we did, and the house failed the radon inspection. The buyers offered to take care of the radon issue if we gave them a credit for it, which we did with a credit of \$1,000.00 on the purchase price. So – list price of \$149,000.00 with a credit of \$1,000.00, closing costs, and realtor commissions left us with a check for the sale of \$137,555.00 which has been deposited into our Money Market savings account. Bill as listing agent received a commission for the sale. Bill and Tina have very generously donated their portion of the commission back to Shepherd which went into our general funds to cover the costs of the sale.

Your Council will be discussing what to do with the proceeds from the sale (you are once again welcome to attend the council meetings). They will hopefully have information to share with you at the annual meeting in January for any proposed expenditures and will be asking for your approval before allocating any funds to specific projects.

Budget Meeting

I held the annual Budget Meeting on Saturday, November 2nd. Having had that awful cold virus for the week and a half prior to the meeting, organization was not my strong suit. I called and invited various congregation members the week of the meeting and had 8 people attend. After reviewing and amending the preliminary figures, the budget for 2020 will next go to your Council for review and further adjustments, and finally on to you at the annual meeting.

Next year, I hope to put notices in the newsletter and bulletin announcements to invite any and all who are interested in the budget process to attend the meeting. I would love to have all of you take part in this process.

Income Tax Law and Charitable Donations

My last item is one of your favorites – income tax law! Due to the changes in income tax law over the last two years, a great many of you who once claimed your charitable donation deduction through itemizing deductions are no longer able to do so due to the substantial increase in the individual standard deduction. I know this affects me. I recently found an article that directly addresses this situation for those of you who are 70 ½ years of age and have traditional IRAs.

Kiplinger Tax Letter Volume 94, Number 22

Charitable donations made directly from a traditional IRA can save taxes. People 70 ½ and older can transfer up to \$100,000.00 from IRAs directly to charity. If married, you and your spouse can give up to \$100.000.00 each from your separate IRAs. Qualified charitable distributions (QCD) can count as required minimum distributions, but they are not taxable and they are not added to your adjusted gross income, so they won't rigger a Medicare premium surcharge. You can't deduct the donation. The IRA-to-charity strategy can be a good way to get tax savings from charitable gifts for taxpayers not taking charitable write-offs because of higher standard deductions. The money from the IRA must go directly to a charitable organization.

This information is only intended to bring this tax savings option to your attention. Shepherd of the Lakes nor myself are in no way qualified to give tax advice. Please consult your tax preparer for advice and information.
