

#### Minutes of Annual Meeting January 26, 2020

#### MISSION STATEMENT

Empowered by the Holy Spirit and rooted in the Good News of Jesus Christ, we are a loving community that follows Jesus and seeks to hear the Word of God and do it in our daily lives.

Council President Sharon Geist called the meeting to order at 10:33 a.m. There were 37 in attendance. A legal quorum was verified.

Opening prayer by Bill Wendorf.

The agenda was accepted with additions under New Business, including:

- Parish House Sale Jean Maines
- Constitution Doug Tarkowski
- Backpack Program Marsha Krieck
- Changing annual meeting date Sharon Geist

Motion by Barb Steinhilber, seconded by Melody Kysiak, carried.

Motion to dispense with reading and approve the minutes from the January 27, 2019 annual meeting, Melody Kysiak/Jeanne Kroll, carried.

Bill Wendorf briefly reviewed his report on page 12 of the annual report.

Sharon Geist welcomed all and thanked everyone for attending today.

#### Treasurer's Report (Jean Maines):

- 1. Jean distributed the treasurer's reports and reviewed highlights of each page.
- 2. Motion to accept the treasurer's reports by Dick Neitzel/Jeanne Kroll, carried.

#### Audit Report:

- Treasurer's Books: Sharon Geist read a letter from Lyn Hurbanis and Penny Zobel regarding their audit of the books on Saturday, January 25, 2020. There were no exceptions noted for 2019. The letter will be filed with the annual report.
- Endowment Fund Books: They reviewed checks written and found no exceptions. Checks were written to ELCA Disaster Response, FORK, NPHS Student, and the Backpack Program.

Motion by Darrell Smith, seconded by Jack Carlson, to accept the audit report, carried.

# Endowment Fund Committee Report (Darrell Smith):

- Committee Members include Betsy Tarkowski, Don Dixon, Mitzy Pockat, Darrell Smith, and Anita Horan.
- Don Dixon's 1-year term is up so he has agreed to fulfill the remainder of Karen Carter's term, which is two years.
- The committee met two weeks ago and decided to disperse earnings of \$360 to the Backpack Program, \$205 to the ELCA Domestic Disaster Relief Program, \$260 to FORK, and \$100 or 10% to an Eagle River High School student for medical expenses.
- Reports for the Endowment Fund are on pages 20 and 21 in the annual report. This fund has been audited along with the other church books.
- No minimum amount required to give to the Endowment Fund.

#### (Betsy Tarkowski):

Betsy reviewed the finances of the endowment fund.

#### 2020 Budget (Jean Maines):

- 1. Jean briefly reviewed the 2020 budget.
- 2. \$5000 is being suggested for purchase of a new copier for the church office.
- 3. Changes are as noted for Bill Wendorf's proposed wages.
- 4. IRS mileage reimbursement rate is currently 57-1/2 cents/mile.
- 5. Jack Carlson asked why we do not pay Bill what the Synod suggests. Bill declined any raise for 2020.
- 6. When a minister owns or rents his/her own home: The chairman informed the meeting that under the tax law, a minister of the Gospel is not subject to federal income tax on "the parsonage allowance paid to him as part of his compensation to the extent used by him to rent or provide a home." After considering the estimate of Bill Wendorf LLM for his home expenses, a motion was made by Jeanne Kroll, seconded by Jack Carlson, and passed to adopt the following resolution: Resolved that of the total cash salary for the year, \$15,000 is hereby designated as parsonage allowance. Resolved that as long as Bill Wendorf LLM is our employee, the above amount of designated parsonage allowance shall apply to all future years until modified (generally annually).
- 7. Dick Neitzel made a motion to approve the 2020 budget as presented, seconded by Jeanne Kroll, carried

#### Further discussion:

- Donated money is being used to pay Bill's school expenses. Synod recommended Wartburg program cost is \$32,000-\$40,000 total. The ILT pastoral certification program that Bill is taking will cost a total of approximately \$13,000.
- Evie asked if Karen Carter and Jack Carlson were being reimbursed gas mileage for their trips to Chippewa Falls to take their classes to become Licensed Lay Ministers. Bill Wendorf stated he supports this. Jean Maines reported that there are a couple of line items which could be used to do this, so Karen and Jack will be asked to submit reimbursement requests for their mileage.
- Parish House sale resulted in banking of \$137,555 (\$149,000 less expenses). The money will be banked until we have need for it for special projects which are being considered. A couple of projects which do not require congregational approval because the total cost for each will be under \$5000 include closing in the space behind the stairway to the balcony so that space can be specified for the Backpack Program. The second project would be putting shelves at the top of the staircase to the basement.
- Programs which will require congregational approval include enclosures for the South door to the
  community room and also the northwest corner door to the meeting room. One other project may be
  putting in new flooring around the altar area at the front of the sanctuary so it is different than the
  carpeting on the rest of the floor to provide a visual different to avoid people tripping/falling when going
  up or down from that level.
- Moving the audit to just after the second quarter will be done next year, no action needed for this.
- Jean also reported that we are looking at moving the annual meeting to July or August. Doug will be looking closer at the constitution (see his presentation later in these minutes). If this is done, it will require two congregational meetings to accomplish it.
- PayPal is not yet set up. Jean Maines will need to go to the bank and open up a new account to use
  for this purpose. Once that is done, Bill Wendorf will set up PayPal online and then Bob Lindquist will
  set the rest up so that people can send donations to the church through PayPal from a link on our
  website. In the meantime, automatic direct deposit can be done from anyone's account to the church
  account through VANCO. Simply Giving through Thrivent is also available. IRA distributions can also
  be sent directly to the church but there are rules that need to be strictly followed when doing this.

#### Constitution (Doug Tarkowski):

Doug has volunteered to be on the Synod Constitution Committee so that he can learn more about it. He has printed the Synod's model constitution and is comparing that to ours to see what needs updating, etc. He asked that anyone who might be interested in being on the committee to get our SOTL Constitution up to date should contact him. He would like to get started on this in February 2020.

#### Backpack Program (Marsha Krieck):

They now have 15 kids in the program from St Germain. There are six areas in which volunteers are needed. Sign-up sheets are on the board that Marsha presented to everyone on an easel today. Joanne Pierce said that 47% of Northland Pines elementary students need help with meals. The Krieck family will continue to bag the food and take the bags to the school, where the food is then put into backpacks by the secretary and given to the appropriate children.

#### Synod Assembly Delegates (Sharon Geist):

Sharon asked for one female volunteer and one male volunteer to be our delegates to Synod Assembly May 14-16, 2020. Elaine Kuhlmann and Melody Kysiak both volunteered to be the female delegate. Ballot voting was done. With 35 total voting, Elaine received 26 votes and Melody received 5 votes, so Elaine will be the delegate for SOTL this year. No male volunteered so the council will seek out a volunteer for this, possibly Jim Carter, since he attends every year anyway.

#### Council (Sharon Geist):

Leaving council this year is Karen Carter, who has fulfilled two terms, so is not allowed to run again. Sharon Geist and Joan Ebert have completed their first term now and are able to run for a second term. Motion made to accept the slate of officers that the Nominating Committee/Council has recommended, which includes Sharon Geist and Joan Ebert to serve a second term and Jack Carlson to replace Karen Carter. Motion by Jeanne Kroll, seconded by Melody Kysiak, carried unanimously.

The meeting was adjourned with the Lord 's Prayer recited by all at 12:32 PM, motion by Jeanne Kroll, seconded by Jack Carlson, carried.

# **Shepherd of the Lakes Lutheran Church**

To My Shepherd Family in Christ.

In J.R.R. Tolkien's Fellowship of the Ring, a young hobbit named Frodo Baggins comes to possess the ring of power, an evil ring of power. And it is decided that to destroy evil, the ring must be destroyed, and this task falls to Frodo and eight others that come to be known as the "Fellowship of the Ring". The journey to do this is perilous, with many challenges and seemingly insurmountable obstacles. While stopping for a brief rest, Frodo finds himself in a moment of reflection and maybe a little self-pity saying, "I wish that the ring had never come to me, and that none of this had ever happened to me". Gandalf, one of the nine, a tall grey-haired wizard replied, "So do all who live to see such times, but that is not for them to decide. All we must do is to decide what to do with the time that is given to us".

Speaking for myself, but certain I am not alone, more than once did I feel a bit like Frodo the last 10 months, asking why I/we should live to see such times. Then realizing (like Frodo) that there is nothing we can do about what has happened, but what we must do is decide how we move forward through prayer and support of one another, and just how much we will let these extraordinary times shape or change who we are, and who we are called to be in Christ. And, in Christ, together, that is exactly what we have done.

Starting the first week in March, a time we will all remember, in-house worship needed to be cancelled for a time, for the safety of all. During this period, Shepherd went down a new path, one which I did not see coming or was prepared for, and that was TECHNOLOGY! Starting with a simple lap-top computer to record services for those at home, we have made steady progress (with a few glitches here and there) to the point we are at now, which is recording and streaming live on Sunday mornings. All this made possible by your support, and the generosity of others to drag us into the 21<sup>st</sup> century.

With a working plan to keep the church as safe as possible, and with the full support of the church council, we re-opened for limited in-person worship the first Sunday in May. Closing for only a few weeks this November, we have been open, and will remain open going forward. I want to thank the council for their support in this and all matters to do with ministry. Like many of you, and myself included, they saw our worship life as an "essential service" to the wellbeing of our church and community. For this I will always be grateful, and as of this letter, no one has knowingly gotten sick attending worship. THANKS BE TO GOD!

Aside from worship, as you may expect, things were a bit quiet around the church this year. Some weddings that were planned for this summer were cancelled, with others being held outdoors for the safety of those attending. But we did have one brave couple that did get married in the church this year. I am thankful this took place with no one getting sick, but even more thankful for their boldness and strong faith. It is in these small things that I see hope that these times will not completely change who we are and are called to be. A people of faith.

As with other years past we have lost friends and family to illness, accident, and time. Most all memorial services have been postponed until a safer time to gather to morn, remember, and to celebrate their life. May all the dearly departed be at peace in Christ.

I was saddened at the prospect that I may go an entire year without a single baptism. But the Holy Spirit, always at work, not only brought forward one child to be baptized, but two, and on the same day as well. And we are already planning additional baptisms for 2021. Alleluia!

The inner workings of the church and its financial stability seem to be, as of this letter, OK. Things are getting done around church, although with fewer hands-on deck, a little slower than they used to. Like most organizations during these extraordinary times, giving at Shepherd was down some, but because of your generosity and continued support of our ministry together as church, we were able to pay our bills, and still be a blessing to our community. Things like the pre-made dinners that were donated to take the place of our Thanksgiving Day community dinner, and the Pastor's Discretionary Holiday Fund, that although down substantially from last year, made a huge impact on local families for Christmas. And not to be forgotten are the food and gift cards I have received from individuals through out this past year, to hand out to people in need, as needed, just to name a few. All this leaves me extremely grateful, thankful, and humbled.

And we are expanding our building as well. As of this letter, our new south entry nears completion, and should be completed by our annual meeting. And again, almost all of the construction cost of this addition has been donated. What an amazing place this is.

Understanding that all things change, I have never been a fan of change for change sake. Some things have already changed during these extraordinary times, never to be the same again. Other changes may well be temporary, with things slowly returning to what we perceive as normal. And both scenarios apply to the church. But change for change sake simply does not apply here.

Like our young hobbit in the beginning of this letter, we have no control over the times, but we do have something to say about what we do with the time we have been given. So, I make you this promise, that as long as I am called and allowed to serve as your pastor, grounded in the Gospel, led prayerfully by the Holy Spirit, and supported by such wonderful people, I will strive to seek out the means and the changes necessary to minster to all those, who for their own reasons, are not able to attend church. But will also fight to keep what defines us as a community, what is spiritual, what is essential to us, and what is founded in the Gospel. Not to change for change sake out of fear of an air born, unforeseen evil, or from pressure for others, and other sources, that have succumb to it.

Again, like our young hobbit, the journey ahead is uncertain, with the possibility of many pitfalls, many obstacles. But as we have done in the past and to this point, we will meet every challenge head on, together, in the name of Christ, for the greater glory of Christ's church, and in faithful service to Christ, in and through the needs of our neighbors.

May the Lord bless us all, keep us safe, keep us faithful to the Gospel, and steadfast in service to Christ through our neighbor's needs.

#### BACKPACK PROGRAM

The Backpack Ministry has been hugely successful! Shepherd has the responsibility for food going to St. Germain Elementary School every Thursday of the school year. A huge thank you to Marsha Krieck for heading up this ministry!

In partnership with Eagle River Elementary, Land O' Lakes Elementary, and St. Germain Elementary, local area churches are providing meals through the "Weekend Backpack Project." Backpacks are sent home on Friday with "child-friendly, easy-to-prepare" food items that might not be the most nutritious, but would provide necessary calories to help eliminate their hunger. Many of the parents are working several minimum wage jobs, living in basements with only a microwave and a one burner hot plate, and struggling to keep their children fed.

Just to revisit our goal: there are children in our school system whose main food source is the school lunch program. On weekends these children go without. Our goal is to supply these kids with 2 breakfasts, lunches, dinners and snacks. Thanks to monetary donations, we have also been able to include fresh fruit in the backpacks.

This program owes all thanks to the generous members of Shepherd who have kept our boxes filled with supplies. The school staff thanks us profusely every week, and I want to sincerely pass that gratitude on to the people of Shepherd of the Lakes.

Items need to be individually wrapped and easy for a young child to make. See list below. (No large items please as they must be carried home by the children.) Items should be placed into the "Weekend Backpack" boxes found in the church. Checks should be made out to SOTL with "Backpack Project" in the memo line.

Oatmeal packages
Individual cereal boxes
SMALL jars of peanut butter
Peanut butter crackers

Microwave soups Cheese crackers Microwave Mac & Cheese Granola Bars, breakfast bars, Cereal Bars Graham crackers

We are now feeding 15 children with this program. It is wonderful to meet the need that is out there. Soups are always needed. Thanks to the money donated, we have been able to purchase enough every week. Much gratitude to everyone who donates!

We also want to acknowledge the United Church of Christ is currently donating all of the fresh fruit for the kid's meals.

"FORK" which stands for "Feed Our Rural Kids" is a program developed to make sure that school children are fed 12 months of the year and not just during the school year. They will use volunteers to deliver the food during the summer months when school is not in session. In Vilas County there are over 600 kids in need of meals. Due to school closures due to Covid, the FORK program took over meals during the balance of the 2019-2020 school year and throughout the summer months. A big thank you to all of those volunteers with that program.

The back program here at Shepherd will be expanding to fulfill the needs of the community. Watch for more information as the program grows.

During the Christmas season, we ask anyone who would like to donate poinsettias give instead to this ministry in honor of, or in memory of, a loved one. All have embraced this program. This year, the donation total was \$50, which was donated to Seasons of Life Hospice House in Woodruff.

#### **COUNTER'S REPORT**

Shepherd's internal accounting system requires two unrelated rotating individuals to count our weekly offerings, prepare the bank deposit and make certain it has been securely and promptly delivered to the bank.

Little did we know at our last annual meeting how different the coming year would be due to Covid19. As you know, our local governments required many businesses and churches to close for a time, as Shepherd did. This extraordinary time called for extraordinary measures for all functions of the church (including counting procedures) in order to keep it and it's members healthy.

As reported last year, Shepherd's internal controls outline secure procedures for the handling of all offerings, from the collection to the time it is deposited in the bank. These procedures are taken very seriously and implemented whenever there is a collection from a church service or one of our special events and there procedures were also implemented to the extent possible during the Covid pandemic. The collection is placed in a sealed bag by two ushers (one during the pandemic) and placed in our safe immediately after the service. Counting is done during the week following the service and is taken directly to the bank for deposit.

The only special event that occurred during 2020 was our Thanksgiving meal. Free will offerings were received that were deposited separately.

Once this pandemic is behind us and it is again safe to gather, we will return to our normal counting procedures, rotating "counters" on a weekly basis.

#### FACILITIES COORDINATOR REPORT

Once again I can report that our facility continues to serve us well, however, this does not mean that improvements and repairs do not need to be made. By improvements I mean our new, beautiful, south entrance to the Community Room. This room eliminates the difficult to use and dangerous stairway and landing originally installed in this location.

Another improvement is our recently installed WIFI, service streaming and recording systems. This was needed to address the needs of our members and others affected by Covid restrictions. This system can project the Lord's message to the world through Youtube.

One major repair that needed to be made this year was the replacement of the air conditioning unit serving the office wing of the building. (FYI: We have three air conditioning units serving our facility.) As I write this I need to mention something again that I mentioned last year. I would like at least one other person to become familiar with our HVAC systems. We have five commercial grade programmable thermostats that need to be reset from time to time to provide heat or cooling for services or other events held in the building. At the present time I am the only one capable of doing this. Please contact me if you are interested.

One project that will be undertaken this year is the replacement of the EXIT signs in the sanctuary. They will be replaced with signs that include lights to illuminate the paths to the exit doors in case of an electrical failure. Speaking of EXIT signs; I could also use one volunteer who would like to test all of our EXIT signs and lights once a month and do a major 90 minute test once a year. Please see me if you are interested in performing this task.

I would like to take this opportunity to again address the fact that our facility does not have much in the way of storage areas. Because of this, "stuff" accumulates rapidly if it is not taken care of in some way. By this I mean being disposed of by the person who provided it when it is no longer needed or by someone taking the responsibility to see that it is packed and stored so that it can be used in the future. We are at the point now that "stuff" needs to be addressed. Please contact me if you have an interest in anything you may have donated or provided, otherwise, a major clean-up will be undertaken later this year.

As I always say, if you have thoughts or concerns regarding our facility please let me know.

Fall and winter programs have been scaled down to accommodate only small groups. Plans are already in progress for the summer of 2021. Parents, counselors, and children are eagerly awaiting this!

Due to Covid, the 2020 Fourth of July Popcorn Fest was cancelled.

#### **GREETING CARDS**

The greeting card ministry was continued in 2020, with greeting cards made for those who may be suffering health issues, who have lost a loved one, who need encouragement in some way, or just to let them know that we are thinking of them and praying for them. These cards are put in the narthex on Sunday morning and every person in attendance that day is asked to sign the card. Anyone receiving one of these cards understands how special they are and how meaningful and uplifting they can be. Fewer cards were sent this year due to Covid cancellation of services.

#### **MINISTRIES OF CARE**

Cancelled stamps are collected all year and are sent to the Sons of Norway. The profits from the sale of prepared stamps sent to help fund research on tuberculosis. Members and friends of Shepherd have collected a total of 2.7 pounds! Please continue to save cancelled stamps throughout the year. A collection box is on the shelf in the coat room.

Soaps, shampoos, and other personal care (the kind you get at motels when travelling) items are collected and delivered to the Tri-County Council on Domestic Abuse and Violence in Rhinelander on a regularly. A collection box for these necessary items is also on the shelf in the coatroom.

Twenty-seven quilts from our quilter's group (including some from St. Mary's!) were made and brought to the Council in early December. One Confirmation and three Baptismal quilts were presented this year. Seven prayer shawls have been knitted or crocheted for those going through difficult times. Fifteen plastic mats for the homeless were made and delivered to the Warming Center of Catholic Charities in Wausau.

Used eyeglasses and cases are collected year-round and given to the International Lions Club. The International Lions have a building on the campus of the Lions Camp in Rosholdt, WI, where they are sorted by prescription and distributed throughout the world. More than one hundred pairs were sent. Please continue to bring nolonger-used eyeglasses. We also gather new readers (2.0, 2.5, 3,0) for Vital Links to Viet Nam, a ministry financially supported by Shepherd. A box for all glasses is also on the shelf in the coatroom.

#### TREASURER'S REPORT

What a year it has been. When Covid shut us down in March, I spent a few sleepless nights trying to figure out what expenses to cut or decrease and how we would handle the reduced donations that I was afraid of (any of you who are familiar with me had to see that coming!). I should have had more faith, not only in God, but also in you. Within a few weeks, it became clear that the same generosity of time, talents, and money you have shown in the past, was alive and well during this very strange year.

The general funds income and expenses for 2020 (books not closed as of yet) showed as shortage of \$21,486, which is not a bad number since we had forecast a shortage of \$38,802. However, the shortage shown on the general funds budget does not show the complete picture. We never budget for the larger special gifts we are fortunate enough to see some years. This year there were special gifts of \$30,000. We tithe 10% to benevolence organizations, so the \$27,000 remaining of the gifts more than covered any shortfall we had for 2020.

The funds from the sale of the Parish house in 2019 are still intact in the bank. Due to your generosity, we have covered our expenses in 2020 from just your donations. For 2021, we have gone even more conservative in our projections for the budget.

Bill likes to use the phrase "we live in extraordinary times". I have to agree with him that 2020 and the beginning of 2021 have lived up to that. But even more extraordinary to me is your faith and commitment not only to our mission in Christ, but also to all of the missions we support and to our church.

As always, if you have any questions concerning any of the accounting, please let me know. Financial reports for the year will be available at the annual meeting as well as on the church website after the final review of the books for 2020.

Thank you for your extraordinary faith and generosity in these extraordinary times.
