Minutes of Annual Meeting January 31, 2021

Empowered by the Holy Spirit and rooted in the Good News of Jesus Christ, we are a loving community that follows Jesus and seeks to hear the Word of God and do it in our daily lives.

The meeting was officially called to order at 10:38 am by Council President Sharon Geist. There were 19 in attendance. A legal Quorum was verified.

The mission statement was read aloud by all. Bill Wendorf, LLM opened with prayer.

Approval of Agenda:

Motion to approve agenda as it stands. Melody Kysiak/Barb Steinhilber. Motion carried unanimous.

Approval of Minutes:

January 26, 2020 minutes reviewed.

Motion to approve as stands. Melody Kysiak/Barb Steinhilber Motion carried unanimous.

Pastor's Report:

- Bill referred all to his Pastor's report in the Annual Report
- 2020 was an extraordinary year that we were helped through by God's Grace.
- Challenges during the year were to find ways to include all of those at home. Changes were made with the needs of all in mind and will continue to best serve all in the coming year.
- Wonderful things happened: Bill given Sentry gift cards to use where he saw need, south entry addition, and the continuation of the Pastor's Holiday Fund even during a difficult year.
- We hope to do the best we can in the times to come with the Grace of God.

President's Report:

• President Sharon Geist referred all to her report in the Annual Report.

Treasurer's Report:

- Financial Statements for 2020 reviewed:
 - Money Market account lower than 2019 and General Checking higher due to transfer of funds to cover building addition costs until donation received. Funds to be transferred back to Money Market in early 2021.
 - o Fixed Assets increased due to addition, camera, wifi expansion, and new copier.
 - o Accounts Payable increased at end of 2020, paid in early January 2021.
 - In Insurance Claim Payment Income and Building Repair accounts, amounts reflect 2019 portico damage reimbursement and damage repair and reimbursement for 2020 portico damage.
 - O Total Net Income loss of \$63,594.67 is misleading. \$42,689.35 is book adjustment for depreciation, and with addition of Special Gift income of \$27,000.00 the actual Net Income figure is \$6,094.68.
 - Under Miscellaneous Restricted report decreased income from 2019 to 2020 for most events due to Covid.
 - Net Income loss in Misc. Restricted is due to 2019 Pastor Holiday Fund collections being spent in 2020.
- Motion to accept Treasurer's report. Melody Kysiak/Karen Carter Motion carried unanimous.

Audit Committee Report:

The audit report for 2020 was briefly reviewed. A copy of the report is included with these minutes. While there were no improprieties found, once again it was suggested to change the timing of the annual meeting and the audit. Discussion followed about the need to change our constitution in order to change the time of year for the annual meeting. A constitution committee is needed this year and Bill indicated he would like to be an active part of that committee.

Endowment Fund:

The Endowment Fund report is contained in the Annual Report.

President of the Endowment Fund Board, Darrell Smith, requested a change to the list of board members in the report to exclude Karen Carter and include Anita Horan.

Discussion followed to clarify where the funds for the annual disbursement come from, which is earned income of the investment fund.

Special Actions:

- Sharon Geist thanked the outgoing council members, Mike Pockat and Tracey Ahlborn, for their service.
- Election of council members to fill the two openings:
- Both Tracey and Mike agreed to continue for a second term.
- Nominations from the floor were called three times with no new nominations from the floor.
 Motion made to accept Tracey and Mike to the 2021 Church Council made. Marsha Kriek/Karen Carter. Motion carried unanimous.

Synod Assembly Delegates:

- Synod Assembly will be held virtually in 2021. One female and one male delegate were called for.
- Melody Kysiak volunteered for female delegate.
- No male delegate volunteered at this time.
- Delegates may use wifi at church to attend in May.

New Business:

Pesentation of Proposed 2021 Budget including Budgeted Benevolence Recommendations.

Jean Maines began budget presentation with reading of tax law text for parsonage allowances:

"Under tax law a minister is not subject to federal income tax on the Parsonage allowance paid to him as a part of his compensation to the extent used by him to rent or provide a home. Of the total cash salary for 2021, \$15,000.00 is designated as parsonage allowance. As long as Bill Wendorf, LLM is our employee the above amount to designated parsonage allowance shall apply to all future years until modified."

Motion made to include tax language in minutes made. Melody Kysiak/Karen Carter. Motion carried unanimous.

Proposed budget reviewed with any changes between 2020 and 2021 mentioned. Motion made to accept 2021 Budget as proposed. JoAnn Kehl/Tom Pierce. Motion carried unanimous.

Motion made to adjourn meeting. Melody Kysiak/Tracey Ahlborn. Motion carried unanimous. Meeting closed with Lord's Prayer recited by all.

Minutes of Congregational Meeting May 2, 2021

Council President Bill Sima called the meeting to order at 10:30 a.m. There were 27 voting members in attendance. A legal quorum was verified.

Bill Sima began with explanation of why the meeting was called including background on past and planned project expenses, dealing with Covid restrictions for congregational meetings, planned amendments to budget to allow electronic communication and meetings when needed, and introduced himself to all in attendance.

Mission statement read aloud by all.

Opening prayer:

Prayer led by Bill Wendorf, LLM.

Approval of Agenda:

The agenda was explained and motion to approve agenda called for.

Motion made by Sharon Geist and seconded by Jeanne Kroll. Vocal vote called, carried unanimously.

Agenda:

Bill Sima gave review of timing of call for congregational meeting and the effect Covid had on this timing. Also mentioned window of opportunity for projects and review of constitution to verify need for congregational approval for projects costing \$5,000.00 or more even if fully funded by donations.

Technology Project:

- Explanation of why technology needed to be updated to allow virtual attendance of worship services.
- Project completed in December of 2020 with Council approval.
- Total cost of project \$11,840.00.
- Expenditure fully funded by donations.
- Floor opended for discussion and questions.
 - Bill Wendorf contributed need for project to allow for social distancing and safe worship practices due to Covid.
 - He also explained that the community room is now being used by the community for meetings and events as it was intended.
 - o Karen Carter spoke of Lions Club appreciation for use of community room for meetings.
- Motion to ask for retroactive approval of technology project called for.
- Motion made by Eric Eade and seconded by Darrell Smith. Vocal vote called, carried unanimously.

Landscaping Project:

- Bill Sima explained project has been on Council "to-do" list for 3 10 years.
- Project has been discussed and approved by Council.
- Project fully funded by donations.
- Bill reviewed list of improvements to be completed in project and timing:
 - Landscaping to be completed by Pristine Yardscapes and Management, LLC, located in Sayner, to estimated cost of \$10,070.00.
 - O Goal is to improve appearance of front of church and to solve ongoing issues.
 - o 3 Arbor Vitae shrubs to be planted to the left and right of front church entrance in corners created by entrance and building walls, with 9 lower shrubs to be planted along both sides of building in front.
 - o Prune existing trees
 - Extend washed rock border along building out to width of 5 feet to prevent erosion issues with roof runoff.
 - o Install fieldstone border and plantings around new sign installation.
 - o Install in-ground irrigation system to water plantings and front lawn. Lawn to be improved.
 - \circ Work to begin week of May 24th and will take 5 7 days to complete, depending on weather.

- Floor opened for discussion and questions:
 - Darrel Smith asked about irrigation system maintenance and expense. Maintenance to be line item in budget going forward. Cost to be determined. Pristine Yardscape capable of seasonal maintenance. Further inquiry to be made to determine costs.

Sign Project:

- Need for new sign due to deterioration of current sign and difficulty in maintaining message in winter.
- Removal of existing sign.
- Estimated cost to be \$9,000.00 and to begin week of May 17^{th} and completed in 5-7 days for posts to be set, rocks added to area under sign, and electronic sign installed.
- Wooden sign to take longer to complete and installed when fabricated.
- Inclusion of ELCA logo to be added either to wooden sign or electronic sign.
- Acknowledgement of growing number of electronic signs in town.
- Need for additional lighting of wooden portion of sign to be determined.
- Floor opened for discussion and questions:
 - Capability and versatility of sign questioned as well as how easy to operate and who will be trained to program sign. (Eric Eade spoke to Bill Sima and Bill Wendorf after the meeting to indicate he had some experience with electronic signs)
 - O Question of availability of electricity to operate sign and response of electric already in place.
 - O Question of highway set back and location of sign discussed. Reference to location of Plum Lake Library sign in placement of new church sign.

Bell Tower:

- Survey of members of congregation concerning retention of bell tower bed and bell was completed by Tracey Ahlborn and response in majority was to retain bed and bell tower for historical significance to members.
- Estimated cost to refurbish bell and bell tower bed \$1,000.00.
- Refurbishment of rock planting bed:
 - o Don Dixon power washed exterior of rock walls.
 - Mason hired to re-point all exterior masonry between rocks and work is completed as of May 1, 2021.
- Volunteers called for to prep and paint bell and tower and to help with planting bed.
- Replacement of rope and possibility of turning bell tower to allow ringing from church side of bed.
- Suggestions for deer-resistant planting includes Russian Sage and Fox Glove.
- Cost of planting not covered in landscaping cost.
- Project approved by Council.
- Floor opened for discussion and questions:
 - Mention made of Pastor Marin being asked for help in planning plantings in bell tower bed and elsewhere as he is Master Gardener and has wished to see landscaping done here since becoming involved with Shepherd.

Summary of Landscaping, Sign, and Bell Tower Projects:

- Costs for each portion of project estimated to fit within \$20,000.00 donation
- All portions approved by Council.
- Mention made again that Tracey Ahlborn is taking lead project. Thanks offered for leadership.
- Motion for approval of complete landscaping project called for:
- Motion made by Elaine Kuhlmann and seconded by Jeanne Kroll. Vocal vote called, carried unanimously.

The meeting was adjourned with the Lord 's Prayer recited by all at 11:21 a.m.

FACILITIES COORDINATOR REPORT

As I prepare to write this report I'd like to say that it sure doesn't get easier. I believe that I have been writing them since 2013 or so, and, probably because I do not keep a log of everything I am involved in facility wise, I struggle to remember so much of what has gone on. Anyway I'll give it my best shot and hope you will understand.

You may have noticed the new exit signs in the sanctuary and narthex. The old signs were many years old and had no battery back-up or emergency lighting. The new signs have both and should serve us well for many years. Also replaced were all of the emergency lighting units. The old units had been installed during the remodeling project over ten years ago and were beginning to present many problems. I would like to ask for a volunteer who would take the responsibility of testing the emergency exit lights and signs for proper operation and also checking the condition of the various fire extinguishers on a monthly basis. Training will be provided.

One of the items noted in last year's report as a problem was storage in our facility. This has been addressed by the council, and steps are being taken to improve the situation. Progress may be slow so please be patient.

I cannot forget to mention two large projects that were undertaken this last year. Our new sign was installed and the grassy areas between the church and Highway 155 are now served by an underground sprinkler system. Various types of shrubbery were also planted around the sign and in front of the building. Along with this work I was able to run new wire to the sign and install two new, GFCI protected receptacles at the front of the church. These will help tremendously during our annual Pie and Ice Cream Social. I have to note that it was very enjoyable to work with Mike Everson on the

installation of the new sign. If you will recall, Mike built our new south entry. Especially memorable was lifting the very top horizontal 8X8 beam in place while standing on stable but homemade scaffolding!

Continuing on the outdoors theme, our "shed" will need some major repairs and possible replacement in the near future. This building is used during the July 4th popcorn event, summer outdoor services and for minor storage purposes. The weather through the years has not been kind and we need to bring it back to usable conditions.

FOURTH OF JULY POPCORN FEST

The weather cooperated in 2021 and in spite of Covid, visitors were very happy to be back to eat popcorn and watch fireworks. We took in \$811.50 in donations and sent \$358.70 to Seminary Support and \$358.71 to Tri-County Council on Domestic Violence.

GREETING CARDS

The greeting card ministry was continued in 2021, with greeting cards made for those who may be suffering health issues, who have lost a loved one, who need encouragement in some way, or just to let them know that we are thinking of them and praying for them. These cards are put in the narthex on Sunday morning and every person in attendance that day is asked to sign the card. Anyone receiving one of these cards understands how special they are and how meaningful and uplifting they can be.

MINISTRIES OF CARE

Cancelled stamps are collected all year and are sent to the Sons of Norway. The profits from the sale of prepared stamps sent to help fund TB research and prevention. Members and friends of Shepherd have collected a total of 2.1 pounds! Please continue to save cancelled stamps throughout the vear. A collection box is on the shelf in the coat room.

Soaps, shampoos, and other personal care items are collected and delivered to the Tri-County Council on Domestic Abuse and Violence in Rhinelander on a regularly. A collection box for these necessary items is also on the shelf in the coatroom.

Quilting Group/Mats for homeless

45 sewn cloth and 8 hand-tied fleece quilts were made and brought to Lily House and Frederick House, both in Rhinelander. Our group has expanded and includes several from St. Mary's! One Confirmation and three Baptismal quilts were presented. Eight prayer shawls have been knitted or crocheted for those going through difficult times. Twenty-two plastic mats (made of plastic grocery bags) for homeless were made and delivered to the Warming Center of Catholic Charities in Wausau.

Used eyeglasses and cases are collected year round and given to the International Lions Club. 70 were sent this year. The prescriptions are determined and the frames are prepared for distribution in thirdworld countries. A box for all glasses is also on the shelf in the coatroom.

Used computer cartridges are collected for the International Lions Club. Proceeds are used to help fund scholarships to the Lions Camp (in Rosholt, Wisconsin). This camp serves disabled and mentally-challenged children and adults.

Dear Northern Great Lakes Synod,

I had the honor of installing Pastor Catherine Ford at Faith Lutheran Church in Three Lakes, WI on Sunday, January 9. Not only was this a long-awaited event for Faith because they had been without a pastor for more than two years, but the event needed to be rescheduled because of weather.

So it was with great joy that the congregation gathered, both online and a few in person, masked and spread out in the pews, to celebrate this new partnership of pastor and congregation. In the Northern Great Lakes Synod, we schedule our installations of new pastors in the afternoon so that neighboring clergy can also attend, offering their support and a visible reminder that the church is more than one congregation, so that as a whole synod we rejoice together. The color of the day is always red in acknowledgement of the work of the Spirit that forged the new partnership and brought us all to this

moment of celebration. And just after the Installation Rite is completed, I present the new pastor to the congregation. When the applause has faded, I invite the pastoral leaders who are present to introduce themselves and offer a word of greeting.


At the installation of Pastor Ford, her mentor, Pastor Kari Vadis, was the first to speak. And into this moment still glowing warmly with good wishes and fresh from enthusiastic applause, Pastor Vadis recounts what was said at her installation. To the newly installed Pastor Ford, she says, "Here is your congregation." And as everyone smiles, she adds, "They will disappoint you. They will let you down." I confess this is not what I was expecting. I wondered where she was going with this. It was like a bucket of cold water being dumped on the good feels and warm happiness of the moment. But then, she went on. "Yes, they will disappoint you. But love them anyway. Forgive them, anyway." And then she added as she addressed the congregation, "Here is your pastor. She will let you down. She will disappoint you. Love her anyway. Forgive her anyway." I do not know who said this to Pastor Kari at her installation, but these wise words continue to resonate.

The relationship of pastoral leader to congregation, and congregation to pastoral leader, indeed any relationship that we are in, cannot move forward without forgiveness and love. And in our current times, this has never been more true. We have all suffered disappointments. Between adaptations and adjustments, pandemic protocols and sickness, loss of traditions and loss of loved ones, we are weary. And the reality is, we are not done with this yet. I believe congregations are well practiced now at making decisions together. You know your context, your vaccination rate, and the rate of compliance when it comes to wearing a mask. If I can provide any more clarity to what you already know, I offer this:

- Continue, if possible, with an online worship option.
- Stay home if you feel sick, even if you only have a cold.
- Get vaccinated, if possible. While it will not prevent a person from getting COVID-19, it will diminish the possibility of hospitalization and death.
- Decide together if in-person worship is advisable, given vaccination rates in the congregation and the burden on the local healthcare system.
- Continue to love and forgive each other, even as we are weary and disappointed.

As the year of our Lord 2022 continues, we find our strength from the presence of Christ in each other. God gives us what we need for the challenges we face now, and the challenges ahead. And together we move forward, one step at a time.

TREASURER'S REPORT

What a difference a year makes. Financially we are as strong as ever. Spiritually we are strengthened by the ability to once again worship as a church, as a family, in person and present. I do believe this pandemic has truly reminded us of what is really important and to what lengths we will go to care for others.

You will notice two areas where we have increased the budget.

The first is in the janitorial budget. With the advent of Covid and the fact that it is not going anywhere for the foreseeable future, we had to find a way to keep you all safe in worship and fellowship. This led to the hiring of a new cleaning person who would be able to keep up with all of the additional duties of sanitizing and cleaning on a deep level every week, in fact, several times during the week. With this increased level of cleaning, the budget had to be stretched to cover the additional time and work. Even with the increase, we are still paying less than we would for a commercial cleaning service to come in once a week.

The second area of increase is in hiring Chris Weber of My Tech, LLC for recording and streaming of the Sunday services and for the recorded music during services when we do not have a musician available. We went for over a year trying to handle this with volunteers. The issue is that our volunteer list kept getting shorter and a few people gave up their ability to actually worship while trying to keep up with the technology on a weekly basis. We have been very pleased with the professionalism of Chris and his crew.
